### **LAKE ACTIVITY WAIVER, CONTRACT, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT**

I am aware that during the Lake activities (including swimming, zip line, water slide, low and high dive areas, trampolines, and other inflatables and non-inflatables) in which I am participating under the arrangement of Cajun Oasis RV Resort, LLC, and its agents, employees and associates, certain substantial risks and dangers may occur, including but not limited to: disease and drowning and problems related to near drowning, fractures, burns and punctures, vehicle accidents, lightning, briars and thorns, partial or total paralysis, explosions, snake bites, heart attack, eye injury, including blindness, heat stroke, cuts and infection, strains, cleaning solvents and other chemicals, falling limbs or trees, insect bites and bee stings, contaminated water, equipment malfunction, failure or lack of safety equipment, actions of myself, other players, problems or hazards related to consumption of alcohol or drugs.

1. \_\_\_\_\_ In consideration of and in part payment for the privilege of being permitted to participate in any way in lake activities, and the services, food, arranged for me by Cajun Oasis RV Resort, LLC, have and do hereby assume all of the above risks and release and hold harmless Cajun Oasis RV Resort, LLC, its agents, employees and associates, and associated companies, or any other person from any and all liability, actions, causes of action, debts, claims and demands of every kind and nature whatsoever which I now have or which may arise out of or in connection with my participation.

I hereby release, contract, agree to indemnify (pay all court and other legal costs if I, my heirs, or assigns file suit in a court action), and indemnify (reimburse any awards and legal fees incurred by Cajun Oasis RV Resort, LLC, brought by the minor, signing parent, or other responsible party signing), and do hereby assume all risks for my heirs, executors and administrations and for all members of my family, including any minors accompanying me.
3. If medical evacuation, including ambulance or helicopter, due to new or existing medical conditions is arranged by Cajun Oasis RV Resort, LLC, I agree to be responsible for any such charges and hold Cajun Oasis RV Resort, LLC, harmless from payment.
4. I understand the nature of lake activities and I am in good health and in good physical condition. If I believe the lake activities are unsafe or that I am not capable to continue in the lake activities, I will immediately discontinue participation in the lake activities.
5. I have read and understand the posted rules, including safety related rules, and agree to comply with all regulations. Failure by others to enforce my adherence to the rules does not negate my responsibility to follow the rules. The risk of injury from the lake activities is significant, including the potential for permanent disability and death, and while personal discipline will minimize this risk, the risk of serious injury does exist. This is a public area in which only minimal security may be provided; the same precautions against crime should be exercised here as anywhere else. Thieves are everywhere, so I agree to personally secure my valuables.
